And whereas, a Covid-19 review meeting was held under the Chairmanship of Hon'ble Chief Minister-Cum-Chairman, SDMA, Himachal Pradesh on dated 30-04-2021 at Bachat Bhawan, Nahan in which directions were issued to increase the Oxygen bed capacity in the existing Covid Health facilities and also by requisitioning the health facilities of the private Hospitals.

And whereas, vide this office earlier order No. SRM-DRA (DDMA) COVID-19/2020-715 dated 21st April 2021, the Health Facility at Baru Sahib namely "AKAL ACADEMY HOSPITAL" has already been notified as 100 bedded Dedicated Covid Care Centre (DCCC) to keep and treat Covid positive cases.

And further whereas, the Chief Medical Officer, Sirmaur District at Nahan, H.P. vide his office letter No. HFW-N(Covid-19)/2021 dated 09-05-2021 has recommended for notifying the above health facility as 40 bedded DCHC to cope up with the pressure of treatment of Covid patients.

Therefore, I, Dr. R.K. Pruthi, IAS, District Magistrate, Sirmaur at Nahan in exercise of the powers conferred in me under Section 34 of the Disaster Management Act, 2005 and vide order No. NHMHP-IDSP/2/2020- IDSP-17136 dated 05/05/2021, issued by the Secretary Health, Govt. of Himachal Pradesh; and further in welfare of the public at large, do hereby upgrade the above 100 bedded Dedicated Covid Care Centre (DCCC) as 40 bedded Dedicated Covid Health Centre (DCHC) to keep and treat the Covid-19 positive cases.
